Box 2 Annual Precept	71,265	85,895	14,630	20.5%	<p>The Myland Community Council Precept had been frozen at £15.89 per Band D property per year for four years. The Community is expecting delivery of two Community Centres, via S106 Agreements, in the next few years. The S106 provides the land and buildings only so to help with the fixtures and fittings for, and expected management of, the facilities MCC raised the precept to start a Community Centre Fund . The precept was raised to £18.39 per Band D property per year, representing an increase of 15.7%. This equates to £1.53 a month or just 0.05p a day increase per Band D property.</p> <p>The variance is more in percentage terms because the number of Band D properties in Myland also increased from 4485 in 2014/15 to 4670.6 in 2015/16.</p>

Box 6 Other Payments	69,921	23,559	-46,362	-66.3%	The main reason for the Variance was the specific grant funding (£46,862) for the Bergholt Road Play Area Project was transferred to Colchester Borough Council in June 2014.  In 2015/16 less was spent on Building & Maintenance, Office Equipment, the Mylander, Training, Contingency and VAT. More was spent on Street Furniture, Meetings, Professional Fees, Other costs and Projects.  Full details of 2014-15 and 2015-16 payments are shown below.
